\*Please note that your company needs to have a drug and alcohol policy in place before testing employees. We don't write policies you would have to do that on your own. It is your responsibility to keep us updated on any changes with your company to include but not limited to address change, email change, and closure of your business especially if DOT. Please notify us in writing if your company is no longer in business. Please feel free to call or email us anytime we check messages often. I do provide my personal cell phone on our voicemail for after hours emergencies. Please try that 1st but if I can't be reached and you need immediate testing I recommend going to ER at Bozeman Health. We have no affiliation with Bozeman Health so they should only be used in dire emergencies when we can't be reached. IE: DOT post -accident with testing.

#### **RANDOM TESTING BASIC INFORMATION:**

Random selections are made quarterly. We are required to pull a certain % of drug and alcohol. These vary by DOT authority. We will make contact with you by email prior to pulling randoms for you to update your employee roster (hired, terminated, work comp) please get those back to us asap to ensure we are being compliant with DOT regulations. Once random selections have been made we will email and or mail you the forms so you know who was selected for testing. You must complete all random testing by the end of the current quarter. If you miss sending in an employee for testing do so asap even if you missed the deadline. We are always here if you have questions. Thank you for choosing Tri Med Services for your company's drug testing needs.
